# OLD BUSINESS AGENDA ITEM NO.1 FY 2025-2026 Proposed Budget Ordinance (No. 1323) (Second Reading)

The following proposed FY 2025-2026 Budget Ordinance is submitted for your consideration. Items of interest include:

- A revenue neutral property tax revenue estimate
- \$1.2M in the street paving budget
- A 2% COLA for all employees
- Eight grant projects with a combined match of \$483,700
- Consolidation of Dispatch Services
- The cost of interim financing and construction of Fire Station #1, and design development costs for our new municipal building.

#### ORDINANCE NO. 1323

AN ORDINANCE OF THE CITY OF PARIS, TENNESSEE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2025 AND ENDING JUNE 30, 2026

WHEREAS, *Tennessee Code Annotated* Title 9 Chapter 1 Section 116 requires that all funds of the State of Tennessee and all its political subdivisions shall first be appropriated before being expended and that only funds that are available shall be appropriated; and

WHEREAS, the Municipal Budget Law of 1982 requires that the governing body of each municipality adopt and operate under an annual budget ordinance presenting a financial plan with the information required by that state statute and that no municipality may expend any moneys regardless of the source except in accordance with a budget ordinance and that the City Commission shall not make any appropriations in excess of estimated available funds except to provide for an actual emergency threatening the health, property or life of the inhabitants of the City of Paris; and

WHEREAS, the City Commission has published the annual operating budget and budgetary comparisons of the proposed budget with the prior year (actual) and the current year (estimated) in a newspaper of general circulation not less than ten (10) days prior to the meeting when the City Commission will consider final passage of the budget; and

NOW THEREFORE BE IT ORDAINED BY THE CITY OF PARIS, TENNESSEE AS FOLLOWS:

SECTION 1. The City Commission of the City of Paris does adopt the following revenue schedule for fiscal Year 2026. The property tax revenue being proposed has been prepared based on a revenue-neutral property tax rate. The governing body intends to adopt the Certified Tax Rate when it becomes available by a separate ordinance:

This annual operating and capital budget ordinance and supporting documents shall be submitted to the Comptroller of the Treasury or Comptroller's Designee for approval pursuant to Title 9, Chapter 21 of the Tennessee Code Annotated within fifteen (15) days of its adoption. If the Comptroller of the Treasury or Comptroller's Designee determines that the budget does not comply with the Statutes, the Governing Body shall adjust its estimates or make additional tax levies sufficient to comply with the Statutes or as directed by the Comptroller of the Treasury or Comptroller's Designee.

SECTION 8. All unencumbered balances of appropriations remaining at the end of the fiscal year shall lapse and revert to the respective fund balances.

SECTION 9. All ordinances or parts of ordinances in conflict with any provision of this ordinance are hereby repealed.

SECTION 10. This ordinance shall take effect July 1, 2025, the public welfare requiring it.

# NEW BUSINESS AGENDA ITEM NO. 1 Interlocal Agreement to Consolidate Dispatch Services

After the regular June meeting on June 5 where an interlocal agreement between the City of Paris, Henry County, and the HC Emergency Communications District was passed to consolidate dispatch services, it was discovered that the TN Bureau of Investigation (TBI) required some specific language that was not included in the previous interlocal agreement. Before the HC ECD can apply for and receive a new ORI number for the consolidated dispatch center the following resolution must be approved.

#### **RESOLUTION 1725**

# INTERLOCAL AGREEMENT BETWEEN HENRY COUNTY EMERGENCY COMMUNICATIONS DISTRICT TN., HENRY COUNTY SHERIFF'S DEPARTMENT TN. AND THE PARIS POLICE DEPARTMENT, TN.

THIS AGREEMENT is made and entered into by and between HENRY COUNTY EMERGENCY COMMUNICATIONS DISTRICT (hereinafter referred to as "ECD"), the HENRY COUNTY SHERIFF'S DEPARTMENT (hereinafter referred to as "SO") and the PARIS POLICE DEPARTMENT (hereinafter referred to as "PD") for the purpose of creating a central dispatch operation under the ECD, subject to the following premises, terms and conditions:

*WHEREAS*, the PD Dispatch has the authority to provide dispatch operations for emergency vehicles in the City of Paris and Henry County; and,

WHEREAS, the PD Dispatch provides dispatch operations for the EMD discipline for both the City of Paris and Henry County; and

WHEREAS, ECD plans to implement Law and Fire disciplines for the City of Paris and Henry County; and

**WHEREAS,** The PD Dispatch currently provides dispatch operations for all emergency agencies except the SO, and wishes to provide dispatch operations for the SO by combining the PD and SO to form a central dispatch center under the ECD, "Henry County 911"; and

WHEREAS, the PD Dispatch currently receives all 911 calls for the City of Paris and Henry County; and

**WHEREAS,** ECD, PD and SO have determined it to be in the best interest of the citizens of The City of Paris and Henry County to enter into the proposed Resolution.

**NOW**, **THEREFORE**, in consideration of the mutual covenants and promises contained herein, the parties agree as follows:

- 1. **Purpose.** ECD agrees to provide dispatch services for the geographic area defined as Henry County Tennessee.
- 2. Authority to Enter into Agreement. This agreement is made and entered into pursuant to the authority granted by the parties under the *Inter-local Cooperation Act*, Tenn. Code Ann. § 12-9-101, *et seq.*, and the parties agree that all approvals and filings required by the terms of said Act shall be achieved as soon as possible from and after the execution of this Agreement.
  - 3. **Term.** This Agreement shall be effective from July 1, 2025 to June 30, 2030, and shall automatically be renewed for five (5) year terms unless one party shall notify the other in writing of its decision to terminate the Agreement, which must be received at least nine (9) months prior to the expiration of the then-current term.
  - 4. Cost of Equipment. ECD shall pay for all equipment repair and upgrades, including but not limited to, phone, radios, CAD, recorder, furniture, etc. ECD will notify Henry County 911 department heads of any major changes in equipment protocol.
- 5. **Major Equipment Outages.** ECD shall notify Henry County 911 personnel of any major equipment outages, failures, or missed calls to 911.
- **6. 911 Director.** 911 Director and Supervisor shall be available to answer questions about how calls were handled after reviewing a call.
  - 7. Employment of Dispatchers. ECD shall determine the number of 911 dispatchers recommended to be employed. If the recommended number of 911 dispatchers increases from its current number of 911 dispatchers, ECD shall provide such recommendation and reasoning to the SO and PD for consideration by both the City of Paris, Tennessee and Henry County, Tennessee. The City of Paris, Tennessee shall employ and the ECD shall supervise all personnel deemed appropriate and sufficient to perform all dispatch functions required by those entities utilizing dispatch. Such personnel shall meet all requirements under Tenn. Code Ann. §7-86-205.

- 8. Recording of Calls. ECD shall maintain recording equipment that is capable of recording all calls.
  - 9. Emergency 911 Calls. Henry County 911 shall promptly dispatch all Law, Fire, Rescue and Medical calls in Henry County. Promptly connect, reroute or transfer to the appropriate agency all calls that are not within the jurisdiction.
  - 10. Training Standards. ECD shall maintain the TECB required minimum training standards to be completed by all dispatchers. ECD will maintain records on training throughout the dispatcher's employment. The 911 Supervisor will complete the annual TCPR report.
  - 11. Employee Performance Review. An Annual, or as needed, performance review will be conducted. The ECD Director will review the 911 Supervisor and IT Manager, and have a record of the review on file. The 911 Supervisor will review all other personnel and have a record of the review on file.
  - 12. Operational Review. ECD Director shall conduct an annual, or as needed, review of Henry County 911 operations in respect to reports, training, staffing, and adequacy of equipment functionality. A summary of findings will be provided to the ECD Board at the end of each fiscal year.
  - 13. **Dispute Resolution.** In the event a dispute or disagreement arises from the operations described herein; a dispute committee shall be formed by the ECD Chairman, upon consent of the City Manager of the City of Paris and the County Mayor of Henry County Tennessee, consisting of persons representing the City of Paris, Tennessee, Henry County, Tennessee, and the ECD. Thereafter, and as necessary, either party may seek any legal remedy available under the law.
  - 14. Severability. The parties agree that if any part, term, or provision of this resolution is determined to be illegal or in conflict with any law of the State of Tennessee by any court with jurisdiction, the validity of the remaining portions or provisions shall not be affected. The rights and obligations of the parties shall be construed and enforced as if the resolution did not contain that particular part, term, or provision held to be invalid.
  - 15. Choice of Law/Venue. This Agreement shall be construed under the laws of the State of Tennessee and the exclusive venue shall be the Circuit Court of Henry County.
  - **16. Entire Resolution.** This resolution is drafted and intended to be consistent with that certain Interlocal Agreement Between the City of Paris, Henry County, and Henry County Emergency Communications District Regarding 911 Dispatchers, executed in June 2025. This resolution may be amended only by written instrument signed by all parties.

This resolution shall be binding upon the parties and shall take effect from and after its ratification and signing by the Henry County ECD Board Chairman, the Paris Chief of Police and the Henry County Sheriff, and after obtaining approval pursuant to the requirements of the Interlocal Cooperation Act.

**Discussion:** Kim Foster provided an update regarding the interlocal agreement. She noted that although the agreement was approved at the previous meeting, a subsequent review revealed that the Tennessee Bureau of Investigation (TBI) required additional language to be included. Fortunately, this was identified before the County Commission and the E911 Board finalized their versions, allowing for the necessary corrections to be made. The City must now revise its version of the agreement to incorporate the TBI's requested language.

Ms. Foster also addressed the topic of the ORI (Originating Agency Identifier) number. She explained that currently, both the Sheriff's Department dispatch and the City of Paris each have their own ORI numbers. Once the dispatch services are consolidated, there will be a single ORI number shared by both entities. However, there is a delay in the consolidation process as they await confirmation of the new ORI number, which is expected to take approximately one month.

In the meantime, Ms. Foster reported that Barbara Wyrick from Human Resources and Catherine McCann, Account Clerk/Payroll, met with the new dispatchers this week to provide them with personnel policies and insurance information for review. The dispatch consolidation will not proceed until the new ORI number is officially established.

**Action:** Commissioner Sam Tharpe made a motion, seconded by Commissioner Vickey Roberts, to approve the Interlocal Agreement to Consolidate Dispatch Services.

### NEW BUSINESS AGENDA ITEM NO. 3 2025 Property Tax Rate

As of Monday, June 23, 2025, the State is working on calculating the Certified Property Tax Rate for Henry County and the City of Paris. The local Board of Equalization completed their process and dismissed on Friday, June 20. If a rate is available by meeting time it will be presented and the process to pass a tax rate will begin.

**Discussion:** Kim Foster announced that the City of Paris has officially received its certified property tax rate from the state, set at \$0.57. This figure closely aligns with the previously anticipated preliminary rate. The new tax rate will be presented in ordinance form at the July 10th meeting, and the ordinance reflecting this rate will be submitted at that time. Ms. Foster noted that if the City Commission wishes to adopt a rate different from the certified rate, additional procedural steps will be required.

Vice Mayor John Etheridge added that the new tax bills will be mailed out in September and will be due by February 28, 2026. Ms. Foster also mentioned that all tax bills are now consolidated in one location, and that Randi French's office will accept partial payments.

### Notes from the City Manager:

City Manager Kim Foster presented an updated paving schedule to the commissioners. She highlighted a specific line item for paving Chickasaw Road, which includes laying a new layer of asphalt and milling select areas. The proposed paving would extend from Knotts Street to Wood Street, with an estimated cost of approximately \$200,000.

Ms. Foster raised a key question for the commissioners: whether to proceed with the paving project now, given that a BPU (Board of Public Utilities) project is also planned for the same area. A discussion followed regarding the timeline of the BPU project. The decision to move forward with paving Chickasaw will ultimately depend on the timing and progression of that utility work.
